Scott, Acting as Mayor of BALTIMORE, MARYLAND (Inc), et al.** This is a Treaty Law Diversity of Citizenship / Nationality (Constitution) Case; Pursuant to Article III section 2, clause 1 and 2, and Article VI, clause 2 of the Constitution for the United States of America.

Treaty Law

Whenever a right grows out of, or is protected by, a treaty, it prevails against all laws, or decisions of the courts of the states, and whoever may have the right under the treaty, is protected. But, if the person's title is not affected by the treaty, if the claims nothing under the treaty, his title cannot be protected by it. Ibid.

Supreme law of the Land

The obligation of a treaty, the supreme law of the land, must be admitted. The execution of the contract between the two nations is to be demanded from the executive of each nation; but where a treaty affects the rights of the parties litigating in court, the treaty as much binds those rights, and is as much regarded by the Supreme Court as an act of Congress. United States v. The Schooner Peggy, 1 Cranch, 103; 1 Cond. Rep. 256.

This Constitution and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

Note: Consul Bill of Credit is Attached under Article 20 and 21 of the Treaty of peace and Friendship of 1787 and 1836 between the United States at North America and the Moorish Moroccan Empire.
